Adoption Agreement:

The pet will be rehomed to you on a **two-week trial period** and can be returned to the Taranaki Animal Protection Trust if the pet is deemed unsuitable for a full refund.

You understand that a member of the Taranaki Animal Protection Trust may inspect your premises to ensure the pet will be housed in safe and secure surroundings pre-adoption and may visit during the two-week trial period.

You agree to contact the Taranaki Animal Protection Trust **immediately** should any problems arise during the two-week trial this includes the pet becoming lost or if you have any health or behavioural concerns.

In the event that the pet requires medical attention during the two-week trial period, you agree to contact the Taranaki Animal Protection Trust **immediately**. Any veterinary costs incurred by you will not be refunded unless first **approved** by a Trustee and the pet is treated by our nominated veterinary practice.

All cats that are adopted through the Trust are spayed or neutered, wormed, microchipped and have received their first vaccination. As our cats in many cases come from rescue situations, we can often not establish parentage. We monitor and treat all our cats for medical issues before releasing them for adoption. Due to the significant expenses involved, we are unable to conduct disease testing on our cats unless, under observation, they exhibit signs that may be considered a symptom of disease.

If at any time during or after the two-week trial period, the Taranaki Animal Protection Trust becomes aware that the pet is being mistreated or is deemed to be at risk, the Taranaki Animal Protection Trust may seize that pet without notice. The pet will only be returned to the adopter after the Taranaki Animal Protection Trust considers the situation resolved and the pet faces no further threat. If the Taranaki Animal Protection Trust feels the situation cannot be resolved, then they can list the pet for rehoming, and you will receive no money or refunds.

By signing this contract, and at the completion of the two-week trial period, you are agreeing to the following:

- You agree to keep this pet's microchip details updated and correct at all times.
- You agree to provide all regular veterinarian treatment, including vaccinations, parasite control and immediate treatment of any illness or injury at your cost.
- You agree to adopt the pet and will consider the pet to be a part of the family and, as such, be welcomed into the family home and sleep inside the home or in an enclosed, safe, protected area at night.
- You agree that if at any point during the pet's life you are no longer able to care for the pet, you must return this pet to the Taranaki Animal Protection Trust.
- You agree that you must not surrender, give away or sell this pet to anyone other than the Taranaki Animal Protection Trust.
- You will understand that the Taranaki Animal Protection Trust cannot be held responsible for the pet should the pet suffer ill health and/or develop an unsatisfactory temperament.
